








# **COLLEGE REDEVELOPMENT PROGRAM**

The College redevelopment program gathered momentum in 2022, with teaching and learning commencing in the new state of the art Technologies and Arts facilities. Students participated in artist workshops to produce a collaborative artwork that will be installed in the foyer of the new Arts block. Simultaneously construction of the new gymnasium commenced. Redevelopment and refits in the established areas of the college are continuing to enhance our high-quality teaching and learning environments.

The redevelopment program has been challenged by the broader issues of the Construction Industry, including labour and material shortages. We acknowledge PS Structures (the Construction Company) for the relentless work to navigate these challenges, and to partner with the College in prioritising the continuity of high quality teaching and learning, while enabling the redevelopment to progress. We look forward to completion of the project in 2023.

#### **LEGACY DANCE SHOWCASE**

The annual Dance Showcase, *Legacy*, was staged for the final time at Swan Park Theatre on Friday the 26 August with a vibrant, energetic, cheering live audience. Students from Year 9, Year 10 and the Certificate II Dance program staged a spirited evening of dance. Again, the evening embraced the melting pot of cultures in our Dance cohort through a program of ensembles, selfdevised duets and solos, guest choreographers from WA, NT and NZ alongside the work of our dance teachers, Mrs Yates and Ms Quinn. Special guest and John Forrest alumni, Musu Kanneh once again mesmerised us with her artistry. And to close the event, awards were presented and the heartfelt farewell given to the Year 12 cohort.





#### PERTH DANCE CHALLENGE

The College megacrew, Hyperfusion, featuring dancers from Year 10,11 and 12, competed in the Perth Dance Challenge.

The Perth Dance Challenge is a Sydney based competition that travels to Perth twice a year. Professional adjudicators judge the items with schools from across Perth competing for titles.

John Forrest Secondary College students once again won their Hip-Hop featuring precise and entertaining choreography.



#### WACSSO SUNDOWNER

The JFSC Swing Band and Certificate in Music Industries students were honoured to perform for the WACSSO conference at the Crown Ballroom. The Western Australian Council of State School Organisations (WACSSO) represents approximately 650 affiliated P&Cs.



#### **GIRLS IN STEM – CAREERS CAFE**

Scientists, surgeons, engineers and technologists came to John Forrest Secondary College to talk to students in our Girls in STEM program about careers in Science, Technology, Engineering and Mathematics.

Opened by Lisa Baker MLA and headlined by Professor Fiona Wood of the Fiona Wood Foundation, Liz Cavalli from Child and Adolescent Health Services and Elizabeth Duguid from Water Corporation the students heard about potential impacts they could make and they way to find careers that might suit them.





#### **TRY A TRADE**

Year 8 and 9 students had the opportunity to participate in a Try-A-Trade day facilitated by the National Association of Women in Construction (NAWIC), Construction Training Fund (CTF) and MPA Skills.

During this girls-only event students were able to try their hands at 3 different trades – Painting, Plumbing and Carpentry. Each course was run by female instructors who work in the industry, providing students with valuable insight to how the different industries could suit them.

Feedback from all participants was that they enjoyed the experience immensely and it helped them explore ideas about their future career paths.



#### **YEAR 8 STORYBOOKS**

"Wow! I never thought I'd be able to finish something like that...but I actually wrote a good book!"

Year 8 English class held a display of their storybooks. One student exclaimed, "Everyone worked really hard on their books to make sure we finished on time for the display, and it was so good". Although some felt nervous, they were proud to display their hard work, delighting in "the cool and creative things others had made." Students also discovered that they could write an effective story when they took the time to apply what they had learnt and drafted their work.

But, creating a narrative and images was only a small part of this task. Students were surprised to find that writing a book was a *"long, hard, process"* which developed their soft skills including persistence, organisation, and accepting and applying feedback.

JFSC has strong connections with primary schools within the local intake area and these partnerships support stability in student numbers. The redevelopment program temporarily limited the expansion of enrolments while some spaces were refurbished. As the building redevelopment program progresses, the availability of additional and specialised learning spaces will continue to support the planned increase in cohort numbers.

# STUDENT ATTENDANCE (SOURCE: SCHOOLS ONLINE)

#### College Target (Business Plan 2021-2024):

We will sustain: Attendance at or above like schools for all cohorts, and to be at 90% by the end of this planning cycle.

There was a decline in attendance rate state-wide attributed to the Covid-19 pandemic, with mandatory isolation and families encouraged to keep students at home with flu symptoms. Although JFSC attendance rates dropped, we have maintained attendance rates above the average for WA Public Schools. This includes across cohort attendance rates.




College Targets (Business Plan 2021 – 2024):





Above National Minimum Standard At National Minimum Standard Below National Minimum Standard

The 2022 Year 12 data outlines the slight increase in JFSC WACE achievement compared to 2021. This rate remains above that of the WA Public Schools result (89%) and Like Schools (90%).

ATAR participation and achievement at JFSC is slightly above the expected rate (see table below). The College's median ATAR for 2022 was 76.8. While this result is in line with our College target, it was disappointing after the success of 2021. Many factors, such as early offers have contributed to this result, and we continue to remain committed to improvement and consistency in ATAR performance.



#### **Online Literacy and Numeracy Assessment (OLNA)**

To achieve a Western Australian Certificate of Education (WACE), students are required to demonstrate a minimum standard of literacy and numeracy based on the skills regarded as essential for individuals to meet the demands of everyday life and work in a knowledge-based economy. The literacy and numeracy standard can be met either through the Online Literacy and Numeracy Assessment (OLNA) or by achieving Band 8 or above in the associated components of reading, writing or numeracy in the Year 9 NAPLAN tests.

## **OLNA – Current Student Standing**

John Forrest SC continues to improve literacy and numeracy outcomes for all students. This target has been met for year 12 students, and we continue to work towards meeting this target for Year 10 and 11 students. Our OLNA achievement rates exceed that of like schools.


